The Environmental Protection Agency (EPA) Small Business Innovation Research (SBIR), <http://www.epa.gov/ncer/sbir>, program issued a pre-solicitation notice for their upcoming environment technology-development contract offerings. The FY 2006 SBIR solicitation is expected to be released on or about March 23, 2006 with proposals due on **May 24, 2006**. The topics for the FY 2006 Phase I solicitation are as follows: Improving the Great Lakes; Control of Air Pollution; Monitoring and Remote Sensing; Green Buildings; Mining and Mine Waste Management; Lead Paint Detection and Removal; Agriculture and Rural Community Improvement; Management of Animal Feeding Operations; Drinking Water Treatment and Monitoring; Pollution Indicators for Beaches and Recreational Waters; Water and Wastewater Management; Innovation in Manufacturing for Environmental Protection; Nanotechnology; Engine and Vehicle Emissions Reduction; Solid and Hazardous Waste; and Homeland Security.
